SaaS Cloud Service Providers - what you need to know.

WHO is responsible for security threats in a SaaS environment? Here's what you need to know.

- a. **If you are using a Public cloud hosting provider:** they are responsible for ONLY the storage space infrastructure as a service (IaaS) for your data and application needs. They will not be responsible in any way to solve a Ransomware issue, you will. Security is NOT their concern, providing the storage is the only concern infrastructure is their only responsibility.
- b. **If you are using a Managed Service Provider (MSP):** it is their responsibility to solve the Ransomware issue. They manage not only your infrastructure but also your data and security. So they must provide a solution for any data/security issues.
- c. **If you have In-house hosting:** if you aren't prepared, it could take as much as 3 weeks to get back online.
